- 1. All admission to the course(s) shall have to be made only through Entrance Examination conducted by Srimanta Sankaradeva University of Health Sciences as per the Notification No. MER.307386/2, dated 06-06-2023 issued by the Govt. of Assam.
- 2. The minimum qualification for selection of the candidates will be as per criteria laid down by the Pharmacy Council of India and Govt. of Assam.
- 3. Age relaxation for different category of candidates is applicable as per existing norms of the Government of Assam.
- 4. The college will be designated as Examination Centre by the University only if the College has minimum 50% students of total intake capacity permitted by SSUHS/ Council and the College is approved as Examination Centre by the University. Otherwise examination of students will be conducted at other designated Examination Centre which shall be notified by Srimanta Sankaradeva University of Health Sciences in due course of time.
- 5. This affiliation will be valid for Academic Session 2023-24 upto 3/1-07-2024.
- 6. Application for renewal of affiliation must be submitted by the Institute before 31-07-2024.
